

A RESOLUTION OF THE COMMISSIONER OF BARTOW COUNTY SITTING FOR COUNTY PURPOSES FOR THE PURPOSE OF **APPOINTING KATLYN SOUTHERN TO THE BARTOW COUNTY PUBLIC ART COMMISSION, COMMONLY KNOWN AS “ART IN BARTOW”** AND FOR OTHER PURPOSES AT THE REGULAR MEETING OF THE COMMISSIONER OF BARTOW COUNTY HELD ON THE 2ND DAY OF OCTOBER, 2024.

**WHEREAS**, the Bartow County Commissioner is dedicated to ensuring Bartow County is a livable and vibrant community for its residents, business owners, and visitors alike; and

**WHEREAS**, the Commissioner is an advocate of public art and endeavors to foster and enrich arts and culture in Bartow County, which brings social, cultural and economic benefits to the public as well as visitors to the County; and

**WHEREAS**, the Bartow County Public Art Commission was established by Resolution on September 16, 2020 in an effort to foster and enrich the arts and culture in Bartow County; and

**WHEREAS**, in accordance with the terms of the Commission, the Commissioner is required to appoint no fewer than twelve (12) members and no more than fifteen (15) members to the Commission, said members shall include broad representation across the community and groups interested in art and tourism; and

**WHEREAS**, Mr. Steven Schumacher’s has transitioned into the Chairperson’s role on the Board thereby leaving a vacant seat; and

**WHEREAS**, Ms. Katlyn Southern has volunteered to fill vacancy on said Board left by Mr. Schumacher; and

**WHEREAS**, the Commissioner deems it to be in the best interest of the citizens of Bartow County and the “Art in Bartow” Commission to appoint Katlyn Southern to complete the unexpired term of Steven Schumacher on the Art In Bartow Board.

**NOW THEREFORE BE IT RESOLVED**, AND IT IS HEREBY RESOLVED by virtue of the authority vested in the Commissioner of Bartow County by law, the Commissioner hereby appoints Katlyn Southern to complete the unexpired term of Steven Schumacher on the “ART IN BARTOW” Board.

**BE IT FURTHER RESOLVED** that said term will be effective immediately and will expire on October 31, 2026.

**BE IT FURTHER RESOLVED** that members of the ART IN BARTOW Commission shall serve at the pleasure of the Bartow County Commissioner and may be removed and replaced by the Commissioner with or without cause at any time.
